- 1. 4" MIN. SUB-BASE (CONCRETE, ASPHALT, OR 90-95% COMPACTED $\frac{3}{4}$ " MINUS AGGREGATE INSTALLED IN 2-2" LIFTS), SLOPE 2% MAX.
- 2. POURED-IN-PLACE RUBBER BASE LAYER (DEPTH VARIES PER MANUFACTURER'S RECOMMENDATION)
- 3. POURED-IN-PLACE WEAR COURSE, (2% MAX SLOPE). WEAR COURSE DEPTH VARIES BASED ON PRODUCT SOLD
- 4. DESIGNATED BEVELED EDGE
